

## Disclosure of FY2022 Group-wide Greenhouse Gas Emissions Releasing information on our response to climate change based on TCFD recommendations

On December 26, 2023, Future Corporation (Headquarters: Shinagawa-ku, Tokyo; Chairman and President, Group CEO: KANEMARU Yasufumi) disclosed its group-wide greenhouse gas (GHG) emissions for FY2022. Furthermore, based on the recommendations of the Task Force on Climate-related Financial Disclosures (TCFD), information on the Group's response to climate change was also released.

The Future Group used the expertise and know-how cultivated through its main business, IT consulting, to calculate GHG emissions in accordance with Scope 1, Scope 2, and Scope 3<sup>\*1</sup> classifications based on the TCFD recommendations. In addition, we also quantified emissions from remote work, which are considered difficult to calculate, based on data such as the operating hours of employees' personal computers and the status of connections to the internal network. As a result, the Future Group's emissions in FY2022 were 13,812 t-CO<sub>2</sub>e<sup>\*2</sup> (down 1.2% from the previous year), and emissions per employee were 5.2 t-CO<sub>2</sub>e (down 8.8% from the previous year).

In conjunction with the disclosure of GHG emissions, we conducted scenario analyses in the four areas recommended by the TCFD: governance, strategy, risk management, and indicators and targets, and disclosed our environmental and climate change initiatives<sup>\*3</sup>.

\*1. Scope 1: Direct emissions of greenhouse gases by the business itself; Scope 2: Indirect emissions associated with the use of electricity, heat, and steam supplied by other companies; Scope 3: Indirect emissions other than Scope 1 and Scope 2 (emissions from other companies related to the business's activities), from the Ministry of the Environment website "Green Value Chain Platform"
