# Consolidated Earnings Highlights

## Consolidated net sales

(Consolidated net sales reached a record high in the first half of the fiscal year.)

Net sales increased for the third consecutive year in terms of net sales for the first half, as sales of Future Architect increased (note), sales of eSPORTS and Brightree remained robust and Micro CAD contributed to consolidated financial results. However, net sales failed to achieve the forecast for the first half.

# Consolidated income

(Consolidated income reached a record high in the first half of the fiscal year.)

Operating income and ordinary income posted all-time highs for the third consecutive year, as income increased thanks to the aforementioned increased sales and the improvement of the profit margin of Future Inspace and other firms.

# Orders received

Orders received remained robust, as orders were received continuously due to expansion of the client base and enhancement of the medium- and long-term relationship of mutual trust with clients.






- Future Architect saw large projects for manufacturing industries expand and the profitability of projects improved due to company-wide development of a scientific project management method.

- Micro CAD saw both sales and operating income remain robust, surpassing their respective targets, due to strong sales of its comprehensive intellectual property management system.



- Tokyo Calendar launched a new online service and renovated its website. With the number of users and page views growing smoothly, the company will continue to take measures to grow the number of users of the website.




Note: Since the said business involves many M&A deals, goodwill occurred. However, amortization of goodwill is not taken into consideration to make year-on-year comparison simple.

Trends of net sales and operating income







#### (Million yen)







#### Trends of sales by industry








#### Trends in sales and data volume






